## AREAS OF SPECIALTY INTEREST

### **Acquired Brain Injury (Including Stroke)**

**Rehabilitation:** I am involved with the assessment and management of patients from an early acute stage within the intensive care environment through inpatient specialist rehabilitation to longer term community and vocational settings. This involves working with different multidisciplinary teams across a range of healthcare providers and higher level negotiation with commissioners and service managers. I have published academic work on outcomes and treatment strategies within this area and have led regional teams in service oversight and delivery.

**Spasticity Management:** I lead a specialist service delivering pharmacological and physical interventions, including botulinum toxin injections and intrathecal baclofen, and supervise and train therapy practitioners. I have published in peer reviewed journals and presented at national conferences on spasticity management.

**Chronic Neurological Disease:** Having a large clinical commitment to patients with a variety of acquired and congenital neurological conditions, I am closely involved with the disease management and symptom control of multiple sclerosis, peripheral neuropathies, neuromuscular diseases, metabolic and degenerative diseases both in secondary care and community services. I am a clinical advisor to NICE committees around these areas.

**Young Adults with Complex Disability:** I have developed transitional services locally and am on the national steering committee for the development of services for young adults and adolescents.
