The Clinical Neuropsychology Service is a specialist assessment, consultation and rehabilitation service for adults with cognitive impairment secondary to known or suspected neurological illness and injury.

Clinically, her role includes assessment, focused intervention and consultation to aid in the differential diagnosis of cognitive disorders, to guide multidisciplinary rehabilitation, to assess mental capacity, and to identify psychosocial factors impeding rehabilitation.
