I am the lead applicant for a grant application to Alzheimer's Disease UK. The proposed project aims at proof of concept for a laboratory protocol, which I jointly developed with Dr L. Lau (University of Southampton), to detect early peripheral biological markers of Alzheimer's disease.

I am currently the primary investigator for a study of the impact of depression on the lives of people with depression and on the family and friends who support the. This study is funded by Janssen-Cilag Limited (2020).

I am currently the primary investigator for a phase 3, randomized, double-blind, placebo-controlled study of the efficacy and safety of sage-217 with a fixed, repeated treatment regimen on relapse prevention in adults with major depressive disorder. Funded by NIHR. (2020).
